(a) **Name:**

The name of the Society shall be The Congregation of the Sisters of St. Joseph of Cluny, Salem.

(b) **Office:**

The Principal office of the Society shall be at Fatima Convent, Pension Line, Salem, Tamil Nadu 636006.

(c) **The Society has been formed with effect from 1st April 2020.**

(d) **The Society is situated within the jurisdiction of the District Registrar, Salem.**

(e) **The business hours of the Society: 10 a.m. to 4 p.m., except Sundays and public holidays.**

(f) **The objects of the Society:**

- (1) To administer and run the institutions conducted by the Congregation of the Sisters of St. Joseph of Cluny established in India in 1827.
- (2) To initiate, support and promote the advancement of education activities in all its branches, particularly schools, colleges, cultural, industrial and agricultural schemes, technical and social service centres and institutions for all women and children irrespective of religion, race, caste, community or social status.
- (3) To provide and encourage medical assistance in the form of hospitals, clinics, dispensaries, health services and similar centres for all

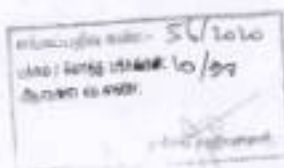
- (g) The activities of the Society are also detailed in the Memorandum of Association.
(h) The President (Chairman) of the Society can sue and be sued on behalf of the Society.
(i) The President (chairman) is empowered to give directions in regard to the business of the Society.
(j) Enrolment of Members:

The members of the society shall consist of:

1. The persons who are signatories to the Memorandum of Association.
2. Such other persons as are members of the Congregation of the Sisters of St. Joseph of Cluny, resident and working in India and admitted to membership of the Society by the Governing Body.
3. Neither entrance fee nor subscription is to be collected from the members.

- (k) Termination of Membership:

1. The Governing Body shall have power to decide by majority of votes to terminate the membership of any member of the society at any time in writing, and on termination of his/her membership such member shall forthwith cease to be a member of the society and also ceases to have any right or claim whatsoever to any rights or privileges of membership of the society or to any property of the society.

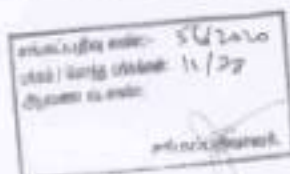

(f) Rights, obligation and privileges of members:

1. Every member has a right to take part in the General Body meetings of the Society.
2. Every member of the Society shall be bound by the provisions of the Memorandum of Association, its Rules and Regulations, and decisions made or taken by the Society in the General meeting or by the Governing Body.

(m) Powers of the Governing Body:

- 1) The Governing Body shall have the entire control and management of the business and affairs of the Society, the administration of all properties movable and immovable, all its institutions and assets and shall have all such powers of the Society, and do all things generally to carry out the objects of the Society, as are by the Act, not required to be exercised or done by the Society in General Meeting.
- 2) The Governing Body shall also have powers from time to time to make, vary, modify, change, repeal and re-enact the Rules and Regulations and frame Bye-laws and change or modify the same for the transaction and regulation of business and affair of the Society and of itself, for the administration of all properties, institutions, and assets, provided the bye-laws made or varied shall not be inconsistent with the existing Rules and Regulations of the Society, and the letter and spirit of the Memorandum of Association of the Society. The bye-laws so framed or amended shall be placed before the General body meeting for approval.
- 3) To raise and acquire funds and movable property of all descriptions and to acquire immovable property of any tenure as the needs of the society may require with or without buildings and structures whether by way of purchase absolutely or on lease or exchange or other forms of acquisition at such rates and on such terms and conditions as the Society may agree to or by acquisition under the Land Acquisition Act in force.
- 4) To erect, construct such building or buildings or structures as may be necessary for the object of the Society and to develop, improve, alter and extend or demolish the same or any part thereof.

- 5) To enter into contracts for carrying on the objects of the society to employ professional persons, officials, clerks and other helpers or agents on such salary and on such terms as they may think proper and, at any time, to suspend or dismiss such persons and to take disciplinary actions, and to do all other things and acts incidental to or connected with the furtherance of the objects of the Society.
- 6) To negotiate and enter into any arrangement with any Government, State, University, Municipality or any other public or private authority, body or association which may seem beneficial or conducive to any of the objects of the Society
- 7) To accept, receive, hold, use, expend and administer any donations or gift whether of monies or other property movable or immovable or any bequest of foundation for the objects of the society or any of them.
- 8) To appoint such person or persons as may be deemed fit for the purpose of representing the society and or the Governing Body in any legal or other proceedings to be instituted by or against the Society and or the Governing body

The Governing Body is also empowered to do, execute and perform all such acts, deeds and things as are set out in particular in the Memorandum of the Society are incorporated in these Rules and Regulations.

- 9) The Governing Body shall meet as often as circumstances require or in any event once a year.
- 10) Notice of the meeting shall be given to members of the Governing Body in writing at least twenty one days before the meeting.
- 11) 1/3 of the Governing Body members shall form a quorum for a meeting of the Governing Body.

(n) The Constitution of the Governing Body

- (1) The Governing Body shall consist of not less than seven members, who shall be elected at the General Body meeting of the Society by a resolution passed by a majority of members present and entitled to vote there at.
- (2) The term of office shall be for one year from the date of election, but they shall be eligible for re-election.
- (3) The Governing Body of the Society shall consist of the President, Vice-President, Secretary, Treasurer and three or more members, who shall be in a position of trustees and not as beneficial owners.

- (4) If by reason of death, resignation, removal or otherwise, any office becomes vacant during any time, such other members as may be selected by a majority of the Governing Body shall hold office for the remaining term.
- (5) The Governing Body shall have full powers to act notwithstanding any vacancy in its members and all acts so done shall nevertheless be valid.

The Governing Body shall consist of:

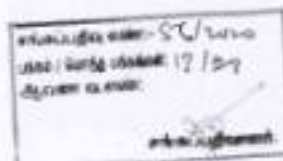
President: To convene and preside over the meeting and to take decisions pertaining to the matters discussed; shall have the right of veto.

- (o) The Governing Body shall ensure that the necessary statements to be sent to the Registrar including a copy of the audited accounts and other statements under section 18 of the act are duly sent at the appropriate time.

The Society shall keep and maintain the following books of accounts

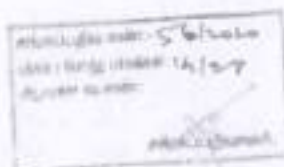
- a) Cash book showing daily receipts and expenditure, and the Balance at the end of each month in the Tally software.
- b) Receipt books containing forms in duplicate, one of each set to be issued with details for money received by the Society and the other to serve as counterfoil.
- c) Vouchers file, containing all vouchers for contingent and other expenditure incurred by the Society and filed chronologically.
- d) Ledger showing consolidated and separate account of all items of receipts and expenditure, member-wise as well as item-wise;
- e) Monthly register of receipts and disbursements.

The Bank Accounts shall be operated by the Treasurer along with the President and for all the units the president shall authorize the superior along with the accountant to operate the bank accounts.

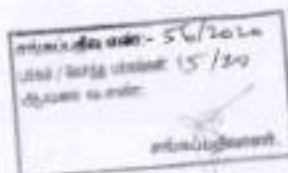

 5. At the meetings of the Society, each member shall have one vote and in case of a tie the Chairman shall have a casting vote. Voting by proxy shall not be allowed.

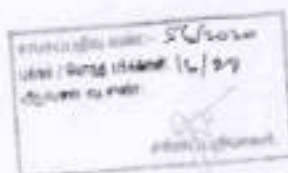
(v) Extraordinary General Body Meetings:

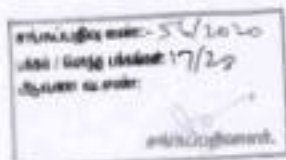
